Ladies and Gentlemen

By the same token, I would also like to acknowledge the various development partners that have partnered with UNCTAD, through the provision of the requisite resources that have enabled this e-Commerce and Digital Economy Programme to see the light of day. In this regard, I would like to specifically single out the Ambassador of the Republic of Korea, His Excellency Ambassador PARK Jae Kyung, who is here with us today. Your Excellency, we are indeed grateful for the generous support extended by your government in support of this program and look forward to continued bilateral and economic cooperations between our two sister nations.

Distinguished Participants;

We are very pleased to note that the UNCTAD e-Commerce and Digital Economy (ECDE) Programme indeed resonates with the aspiration of our National Development Strategy (NDS) 1. The Digital Economy has been aptly identified as one of the priority areas of development, ICTs being a key enabler of industrial and economic development. Hence the entrenchment of ICT across all national development strategies critical for the attainment of the country's Vision 2030, for a prosperous and empowered uppermiddle income society by 2030.

My Ministry prioritises the protection of consumer rights in the country including in the digital domain, in order to foster a trustworthy online e-commerce environment. The need for greater investment in digital technologies and skills development can never be overemphasised, in view of the fact that connectivity is the life-blood of both business transactions and human interactions. There is a beckoning need to enrich our digital space by retooling major facets of our economy in order to bring about the requisite agility and resilience and to deliver greater efficiencies across all value chains.

Ladies and Gentlemen;

On this note, I would like to underscore the need for the ongoing process not to inadvertently sideline the Micro Medium and Small Enterprises (MSMEs), who have since become major contributors to Gross Domestic Product growth not only in Zimbabwe or the Southern African Region, but throughout many parts of the world.

This E trade ready Programme is poised to positively impact on the MSMEs capacity to enhance productivity and be mainstreamed into national economic development programmes. There is need to nurture the MSMEs through this Programme, with a view to enhancing their business processes and therein improve their customer bases and use ICT's to facilitate ther graduation into large businesses. It is our most fervent hope that the UNCTAD e-Commerce Readiness Assessment will come up with workable recommendations regarding policy interventions that can be implemented at both the technical and policy levels. There is need to address the existing digital data divides in order for e-commerce to support inclusive and sustainable development that leaves no one and no place behind!

With this few welcome remarks, I would like to once again thank you all for coming. We greatly value your contributions and look forward to a mutually beneficial cooperation with all the stakeholders here represented. By the same token, I would also like to once again express our gratitude to UNCATD and their development partners for extending this E-Commerce and Digital Economy Programme to the developing countries and for also roping Zimbabwe in.

I wish you all very fruitful deliberations, both here in Harare and in Bulawayo.
